

FIM EUROPE (FIME) TRACK RACING COMMISSION

SUPPLEMENTARY REGULATIONS (SR's) 2020



These SR's must be issued by the FMNR responsible for organising the event, and be in accordance with the FIME Sporting Code., with the event being held under the FIM Europe and FIM rules applicable for Track Racing.

Copies of these SR's must be sent to the FIME Track Racing Chairman (trcfime@gmail.com) at least TWO months (SIXTY days), before the date of the event, for approval. Once approved, the SR's will be sent to the FMNR and the FIM Europe General Secretariat.

The FMNR will be responsible for sending the SR's to the FIM Europe Delegate, Jury President/Referee/Race Director as well as all other persons connected with the event (i.e. Riders, Officials, etc.).

Riding Number Race Jackets: Supplied by the organisers: **YES* / NO (delete as applicable)**
NOTE – when the organiser supplies riding number race jackets, all competitors must wear them during practice, racing, the prize-giving ceremony and any press conferences. The competitors own sponsors or any other advertising must not cover ANY part of the riding number race jacket (except the shoulder straps). For further information refer to FIM Track Racing Appendices rule 70.5.1 ‘Race Jackets’
Note: For SEC Championship events – if the competitor wears an external Neck Protector/Brace, and any part of the protector covers sponsorship advertising on the race jacket, then the organiser reserves the right to position the event sponsors advertising stickers onto the neck protector.

Front Fork Covers (Speedway): Supplied by the organisers: **YES* / NO (delete as applicable)**
NOTE – if the organiser supplies competitors with event sponsored front fork covers (for any FIM Europe Speedway Championship event) competitors must fix them securely to their motorcycles during practice, racing, the prize-giving ceremony and any press conferences where their motorcycle may be photographed,. The competitors own sponsor or any other advertising material must not cover any part of the front fork cover.

Environmental Mats: Please note that for ALL Track Racing events, competitors must provide and use an environmental mat per motorcycle. The use of environmental mats is **COMPULSORY**
 If competitor’s use a generator or other similar petrol/diesel devices within their pit area, then they too must be placed on an environmental mat to ensure that no spills or leakage gets into the ground.

Fuel: Will be available at the track: **YES**
 Against payment: **NO**

During the whole event from entering the stadium until leaving after the completion of all duties all participants and officials must obey the Sanitary Regulations which are attached to this SR and respect all instructions given by the Sanitary Commissioner of the meeting. The organizer will provide face masks which must be used.

***Notes re Riders' Briefing Meetings:**

Only riders competing in either the U19 Individual Speedway Cup, the U21 Individual Speedway Championship OR any of the Youth competitions are required to attend a Pre Practice Riders Briefing.

For Team Events – Team Managers (*not the riders*), must attend all Briefing sessions. It is then the responsibility of the Team Managers to brief their riders of any relevant information that will ensure the smooth running of the event (timings for Practice, Alcohol Breath Testing, arrangements for the Rider's presentation, Winners presentation ceremony etc.)

***Payment of Expenses Reimbursement:**

All amounts can only be paid to the competitors in **€ (Euros)** – equivalent to the exchange rate on the Friday prior to the event

Protests and Appeals: Any person or group of persons – competitor, passenger, sponsor, manufacturer, official, etc. – recognised by the FIM Europe and affected by a decision taken under the authority of the FIM Europe, has the right to protest against that decision before the International Jury (except in the case of statement of fact).

Protests against the eligibility of a competitor, passenger, entrant or a motorcycle entered, must be made before the start of the official practice. Protests against results must be presented to the International Jury within 30 minutes following the announcement of the results.

An appeal may be made against a decision of the International Jury to the FIM Europe Judicial Panel.

All protests to the International Jury must be made in accordance with the requirement of the Disciplinary and Arbitration Code of the FIM Europe and be accompanied by a fee of **350 Euros or 1580 PLN** (*state amount and currency*) to the exchange rate of the Friday prior to the event.

The fee will be returned if the protest is justified or forfeited if the FIM Europe Judicial Panel considers the protest to be groundless, or if it is withdrawn without a hearing

Leaving the Meeting: No competitor may leave the pits, and no machine or engine shall be removed, until after the conclusion of the last race of the event, and then only with the permission of the Clerk of the Course/Race Director.

Environmental Management Map:

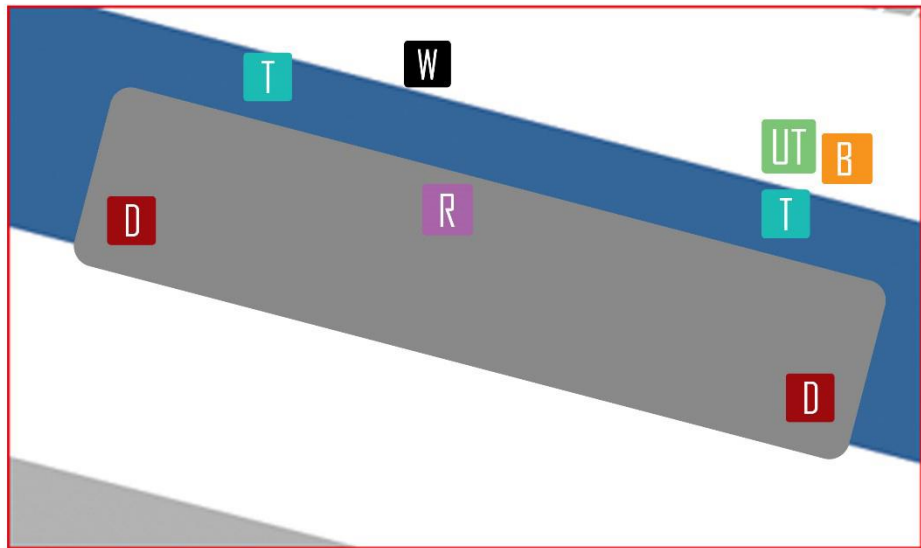
To support the Environmental Management Plan, organisers are required to provide a map of the venue showing clearly the location of the following facilities:

- f. Disposal point for used tyres (if provided)

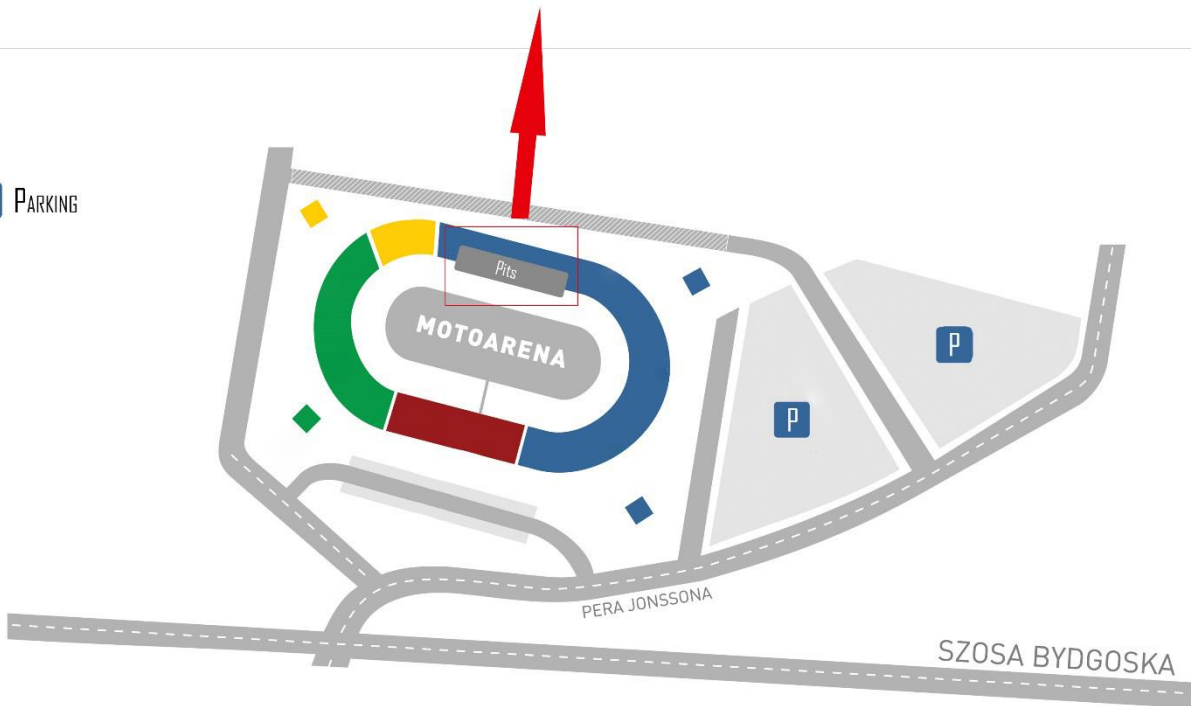
This document must be sent to the FIME Administration, via the National Federation together with the Supplementary Regulations.
