**Protests and Appeals:** All protests to the International Jury must be made in accordance with the requirement of the Disciplinary and Arbitration Code of the FIM Europe and be accompanied by a fee of **350 Euros or n/a (state amount and currency)** to the exchange rate of the Friday prior to the event.

**Leaving the Meeting:** No competitor may leave the pits, and no machine or engine shall be removed, until after the conclusion of the last race of the event, and then only with the permission of the Clerk of the Course/Race Director.
