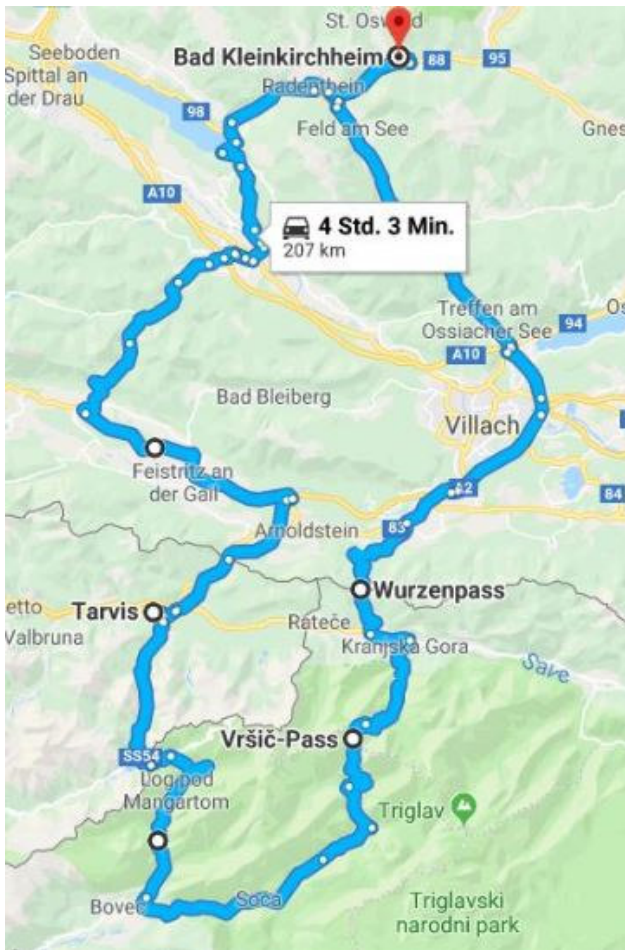

Dinner: “Kärntner Buffet” in the Hotel Prägant

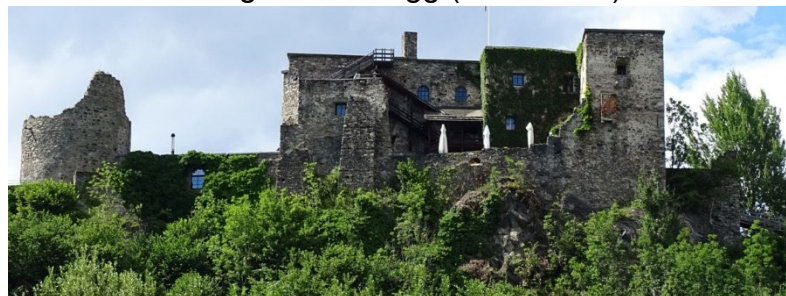
### DAY 2 (Saturday 25<sup>th</sup> September 2021 – approx. 200 km)

Dinner: bustransfer to “Ritteressen” on the Burg Sommereg (incl. drinks)

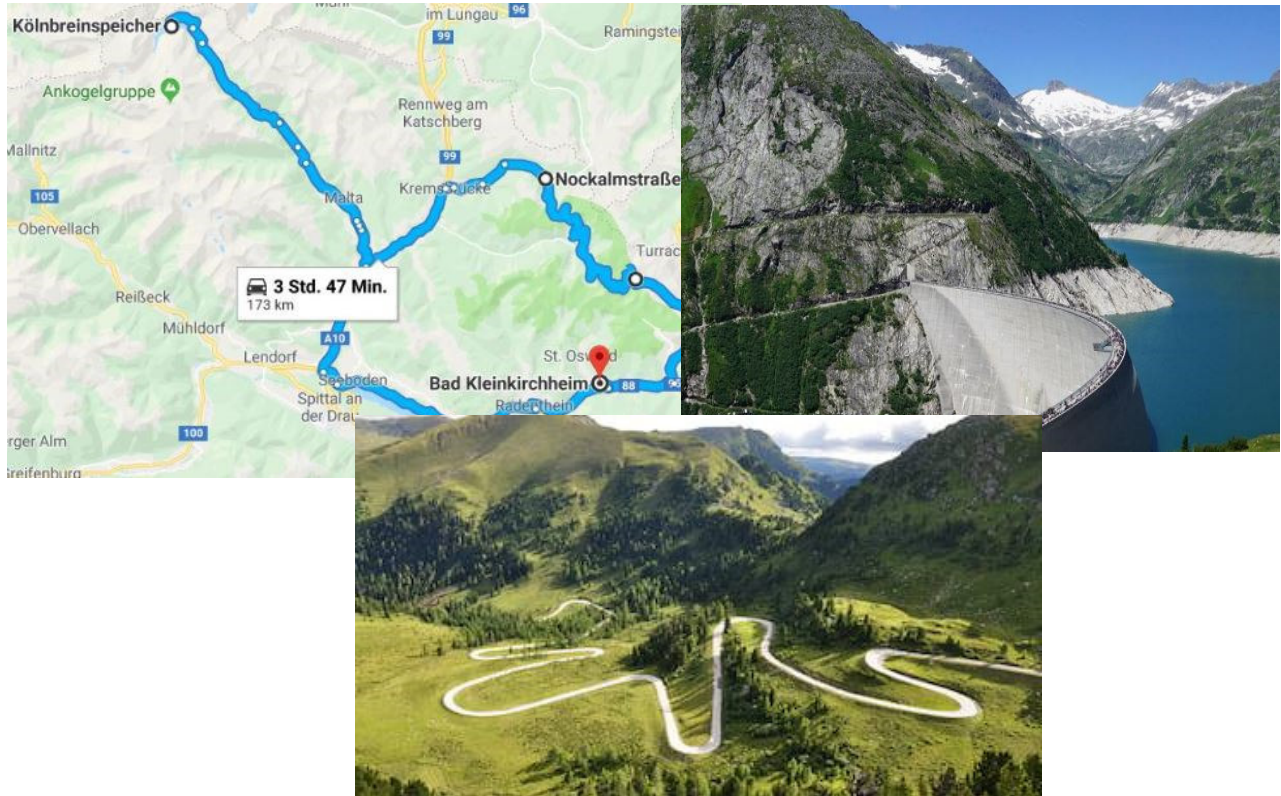

DECLARES

- 3) to have valid and current driving license
- 4) to be in perfect physical and mental health and not to use substances (alcohol, drugs, medicines etc.) which could alter or maim his/her efficiency
- 5) to have examined the proposed itinerary and the road type and conditions, being able to ride the own motorcycle on the aforementioned roads
- 6) taking full responsibility that the motorcycle used for the event is technically suitable, adequate for that and properly insured to European Law and standards
- 7) to undertake wearing suitable clothing and equipment during the tours
- 8) to release therefore FIM Europe and FIM Rallye Team Austria in cooperation with AMF, his organs, people in charge, employees and personnel from whatever responsibility for whichever damages to the undersigned or to the motorcycle (even if owned by a third party) as a consequence of possible accidents
- 9) to release, however in the broadest terms, for his/herself and successors of whatever title, FIM Europe and FIM Rallye Team Austria in cooperation with AMF, his organs, people in charge, employees and personnel from any obligation to pay sums to anyone, including third parties and transported third parties, as compensation for damage, indemnity, refund or whichever other title in the case of any type, nature or entity of accident, caused by whoever and however, including FIM Europe and FIM Rallye Team Austria in cooperation with AMF, their organs, people in charge, employees and personnel on the occasion or during the "FIM Europe Club event in Austria" which the undersigned asks to carry out THEREFORE the refund of any possible damage caused, directly or indirectly to the facilities, to other drivers/riders, to anybody else's mechanical means and to other third parties whether they be participants or members of the organization, will be on his/her total and exclusive liability except in case of gross negligence or deception on the organisers part
