

# FIM EUROPE (FIME) TRACK RACING COMMISSION

## SUPPLEMENTARY REGULATIONS (SR's) 2024



These SR's must be issued by the FMNR responsible for organising the event, and be in accordance with the FIME Sporting Code, with the event being held under the FIM Europe and FIM rules applicable for Track Racing.

**If the organising club/promoter is planning to have the event filmed for either television broadcasting or live streaming, THEN PERMISSION MUST FIRST BE SOUGHT from the FIME TRC.**

Copies of these SR's must be sent to the FIME Track Racing Chairman ([trcfime@gmail.com](mailto:trcfime@gmail.com)) for approval at least TWO months (SIXTY days), before the date of the event. Once approved, the SR's will be sent to the FMNR and the FIM Europe General Secretariat.

**Environmental Mats:** Please note that for ALL Track Racing events, competitors must provide and use an environmental mat per motorcycle. The use of environmental mats is COMPULSORY. If competitor's use a generator or other similar petrol/diesel engined devices within their pit area, then they too must be placed on an environmental mat to ensure that no spills or leakage seeps into the ground.

**Protests and Appeals:** All protests to the International Jury must be made in accordance with the requirement of the Disciplinary and Arbitration Code of the FIM Europe and be accompanied by a fee of **350 Euros or - (state amount and currency)** to the exchange rate of the Friday prior to the event.

**Leaving the Meeting:** No competitor may leave the pits, and no machine or engine shall be removed, until after the conclusion of the last race of the event, and then only with the permission of the Clerk of the Course/Race Director.

### **Environmental Management Map:**

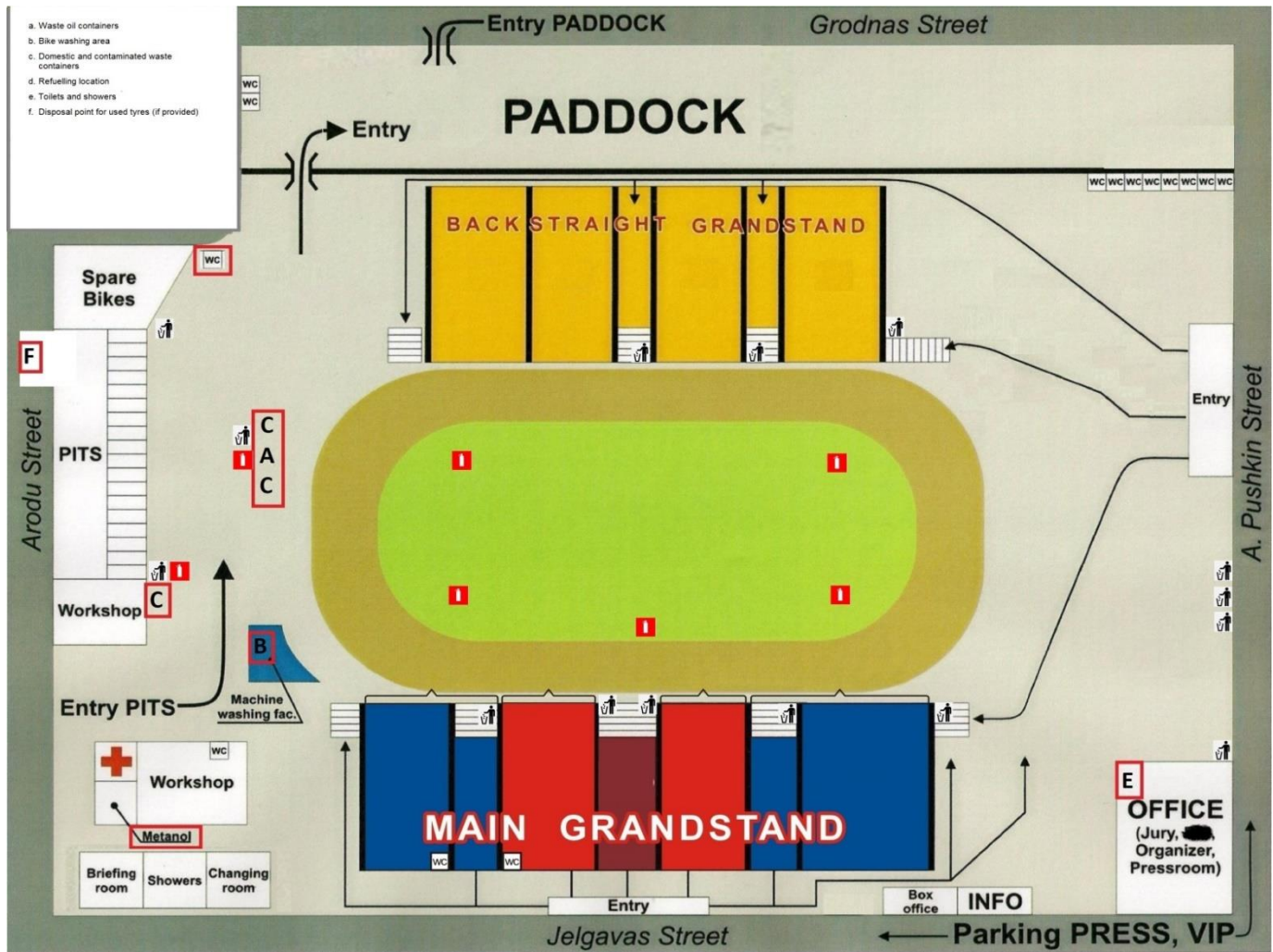
To support the Environmental Management Plan, **organisers are required to provide a map of the venue** clearly showing the location of the following facilities:

**Once the EMM has been approved by the FIME Environmental Commission, the FIME Track Racing Commission will ensure that a copy is distributed to all participants.**

**It should also be noted that a large sized copy of the Environmental Management Map must also be displayed in a visible place at the event for participants and teams to view.**
